d) Growing Together Preschool Program Parent Fee Rate Increase for 2017-2018

Growing Together Preschool program is requesting approval to increase the part day parent fee rate effective July 1, 2017 to \$28.00. The current parent fee part day rate charged for preschool services is \$25.00 a day. The current state preschool part day reimbursement rate is \$26.26, which increased from \$23.87 effective January 1, 2017. The last parent fee increase was done in July of 2014 to \$25.00 a day. However, in order to maintain overall program services, it is recommended that the Board approve an increase of the parent fee rate to \$28.00 a day.
