On July 16 CUEA negotiators, site reps and leadership meet with district in which CUSD responded to the initial MOU. CUEA voiced their concerns regarding masks, sanitation practices, HV air exchange, health checks and a number of other concerns on keeping students safe. Ms. Hale reported CUEA will be meeting with the district to discuss calendar changes to the start of school for the 2020/21 school year and ensure all parents, students and staff are aware of the expectations and responsibilities.

Melanie Hernandez, CSEA Chapter Secretary and Lead Negotiator, reported CSEA has been meeting with the district to discuss safe working conditions for staff and students. Good dialogue and additional meetings planned. CSEA conducted a survey with its members to get a feel for their thoughts and concerns. One third had serious potential health issues or serious concerns on the thought of schools reopening. Twenty percent voiced desire to resign or take advantage of FMLA. Ms. Hernandez stated she was happy to see the CSEA contract on the board agenda (from the 2018/19 school year) and hopes for implementation. CSEA will continue to keep dialog open whether we reopen schools or not.

d) <u>Calaveras Unified School District (CUSD) and California School Employees Association</u> (CSEA), Chapter 405 2018-19 Reopener Tentative Agreement (TA)

CUSD and CSEA concluded its negotiation session on April 14, 2020 and reached a Tentative Agreement (TA) to include changes in salary and language.

Superintendent Campbell advised the Board to not approve the agreement between the district and CSEA 405 due to fiscal impacts of the agreement.
