**5. Public Comments**

Renetta Hale, teacher and CUEA Vice President, wanted to note that she was locked out of the 9/22/2020 Board meeting for a period of time. When she was able to get in, the Board had already moved past the Certificated Report on the agenda. President Williams did not later ask for her report so she would like the opportunity now. Ms. Hale reported at the last board meeting teachers and administrators were given 8 working days to make the transition from 100% Distance Learning to the 50% Blended Hybrid Plan. 50% was not an option that was discussed by the unit prior to 9/22/2020. CUEA had an emergency meeting on 9/25/2020 with CUSD/HR to discuss the MOU. It was agreed Group A meeting Mondays/Tuesdays, Group B meeting Thursdays/Fridays with Wednesdays being a school cleaning day. At the 9/30/2020 CUEA Site Rep meeting were they review and revised the draft MOU which was shared with CUEA membership for their input. CUEA team met on 10/2/2020 with CUSD/HR and refined the draft MOU which was once again shared with leadership for feedback. Questions/clarifications were sent back to CUSD/HR and CUEA is hoping to get a final draft signed and presented to the Board on October 20<sup>th</sup> for approval.

**6. Special Session**

**a) 50% Blended Program/100% Distance Learning Model**

Request was made to reagendaize this item to discuss and address the Superintendent's recommendation on amending the direction provided at the 9/22/20 board meeting.

**b) 50% Blended Program/100% Distance Learning Model**

Recommendation was to approve a proposed amendment to the board approved 50%-Blended Program Model that would have ~~Toyon Middle School~~, Calaveras High School and Gold Strike High School continue with 100% Distance Learning through the end of the 2<sup>nd</sup> Quarter of the 2020/21 school year.

Communication went out prior to Board meeting stating Toyon Middle School will begin 50% Hybrid Model on 10/12/2020, same as elementary schools.

After public comments and Board discussion, Trustee Dunnigan amended his original motion and motioned to have a check-in on the October 20<sup>th</sup> and November 10<sup>th</sup> board meetings with a hard start date for Calaveras High School and Gold Strike High School of November 16, 2020 or sooner if staffing issues are resolved.
